# Lake County Board on Nuisance Violations

The LC Board has adopted a new ordinance to speed up code compliance and nuisance violations in unincorporated areas—of which we are one. The Administrative Adjudication Ordinance covers minor code violations such as junk, debris and animal control. Violators will be issued a ticket, or violation notice, and be given 15 days to comply. The new process will take only 6 weeks to resolve, compared to the old process of sending problems through the Circuit Court, which took almost a year. The Board also created a new category called "chronic nuisances" which allows the County additional remedies to address repeat violations.
